1. The details of the contract sum, budget sum, duration and completion date of the said contract
2. Details of the construction company that handled the project, and money released to the contractor.
3. The contract document that was signed with the contractor.

This request is in line with Section 2(3) and (4) of the Freedom of Information Act 2011 which require all "information relating to the receipt or expenditure of public or other funds of the institution to be widely disseminated and made readily available..."

We would appreciate it if the information is made available in either **hard or soft copy** within seven (7) days from the date of receipt of this application, as provided by the FOI Act.
